Middle School - Reading 73% proficient, Math 70% Did not test Algebra 1. High School – Reading 62% proficient, Math 64% proficient. Scores are above State and District. Next Assessments completed in December for mid-year and final assessment at end of school year. Remediate students using iReady.

- 3. Freedom Show held for all campuses at Old Cutler Presbyterian Church. Received very good feedback from parents.
