II. Reports

School Progress Report – Headmaster Dr. Marc Snyder provided the following updates:

Enrollment projections: 300+ students have applied for next year. Recommitment letter has been received by all families.

Recruitment: Attended Hillsdale College Classical Job Fair on March 2-4. Dr. Snyder conducted nine interviews and is inviting 4-5 candidates down to Miami for visit and further interviewing. Visited St. John's College on March  $16^{th}$ , interviewed 4 candidates and planning to invite them down for school visit and further interviewing . Trips planned for Liberty University on April  $5^{th}$  and Ave Maria University on April  $8^{th}$ .

Personnel – Teachers evaluations have been completed.

Testing  $-4^{th}/5^{th}$  grade FSA Writing test has been completed.  $3^{rd}$  grade reading has been scheduled for March  $29^{th}$  and  $30^{th}$ .  $3^{rd}/4^{th}$  grade math has been scheduled for March  $31^{st}$  and April  $1^{st}$ .

EESAC Meeting has been scheduled for March 14th to review the SIP

Annual Fund - Dr. Snyder discussed how this fund can assist in implementing the Leader in Me program. He will be visiting another school to see how program works. Luis Diaz discussed how we need to educate parents about the Annual Fund and explain why we need it.
