II. Reports

1. College Counseling Office

- College Application Update
 - 100% College going success rate
 - 777 Applications submitted to 151 colleges.
 - Notable acceptances include Harvard University, Cornell University, University of Notre Dame, University of Michigan, and Villanova.
 - Approximately 25% of Senior class were accepted into UF and FSU.
 - Students earned \$9.7 million in scholarships, with 70% qualifying to Bright Futures.
 - The graduating class also includes 5 National Merit Scholars and 38 College Board Scholars.

- College Fair
 - 81 colleges present
- Overall Achievements
 - 3 separate signing days for Athletics
 - True North Baseball team is ranked #3 in the county
 - Students in competitive clubs are extremely successful. Some notable teams include Model UN, mock trial, and spanish club.
 - True North Classical Academy Junior Class is extremely strong.
 - Several students scored over 1500 in the SAT
- School Visits
 - Students see the benefit of visiting schools and meeting with alumni
- 2. School Progress Report
 - Discussion over the upcoming job fairs
 - Information Session on 3/10
 - Interviews being held on 3/17
- 3. Parent and Faculty Satisfaction
 - Mid-year surveys showed high satisfaction from parents and faculty
 - Sunset had the highest faculty scores of all the years.
 - Meeting with department heads and administration has been key.
- 4. School Start Time – 1001.42(4)(f)2, F. S.

The board discussed the School Start Time Requirements in section 1001.42(4)(f)2, F.S. The board discussed strategies to comply with the School Start Time Requirements, the impact of implementing them, and the unintended consequences for the school, students, and the community. Mr. Rudy Pages made a motion to maintain the current school times and to comply with 1001.42(4)(f)2, [F.S.by](#) submitting a report to the Florida Department of Education as provided for in the statute. Mr. Pete Windhorst seconded the motion, which passed unanimously.
